A BYLAW FOR THE LEVYING OF TAX RATES FOR MUNICIPAL, HOSPITAL, AND REGIONAL DISTRICT PURPOSES FOR THE YEAR 2017

The Council of the District of Stewart, in open meeting assembled, enacts as follows:

1. The property tax rates of Schedule "A" attached hereto and forming a part hereof are hereby imposed and levied for the year 2017.
2. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
3. This Bylaw may be cited as "2017 TAX RATES BYLAW NO. 912, 2017".

BYLAW NO. 909, 2017

A Bylaw to amend Bylaw No. 889, 2015, a bylaw to provide for the establishment and operation of a Volunteer Fire Department."

WHEREAS the *Local Government Act, RSBC 1996, c 323*(the "Act") empowers the Council by bylaw to establish fire protection services in the District of Stewart;

WHEREAS Council has resolved to amend the remuneration sections;

NOW, THEREFORE, the Council of the District of Stewart in open meeting assembled enacts as follows:

REMUNERATION

1. Section 32 is deleted.
2. Schedule "A" is amended by deleting "\$5.00 per man per practice and \$10 per man per call out for fire" and substituting "\$20.00 per person per practice and \$50 per person per call out for fire or rescue".

3. This Bylaw may be cited for all purposes as "The District of Stewart Fire Department Amendment Bylaw No. 909, 2017"
