SCHOOL TRUSTEE 2018 GENERAL LOCAL ELECTIONS NOTICE OF NOMINATION

PUBLIC NOTICE is given to the electors of Coast Mountains Board of Education School District 82 that a Trustee election will be held on Saturday, October 20, 2018 to elect Trustees to represent the Board of Education of School District 82 (Coast Mountains) for a four-year term (November 2018 to November 2022) as follows:

- Trustees (two) - Trustee Electoral Area 1 (**Kitimat**) (the District of Kitimat, Kitamaat Village, Klemtu, Butedale and Cable Car Subdivision)
- Trustees (two) - Trustee Electoral Area 2 (**Terrace**) (the City of Terrace, northeast area of Kitimat-Stikine Regional District including New Remo, Kalum Lake Drive and Rosswood)
- Trustee (one) - Trustee Electoral Area 3 (**Thornhill**) (Area E of Kitimat-Stikine Regional District and the South and East portion of Area C of the Kitimat-Stikine Regional District including Copperside, Gossen, Kleanza, Lakelse Lake, Usk and Old Remo)
- Trustee (one) - Trustee Electoral Area 4 (**Stewart/Meziadin**) (the District of Stewart and Area A of the Kitimat-Stikine Regional District)
- Trustee (one) - Trustee Electoral Area 5 (**Hazelton**) (Cedarvale, Village of Hazelton, District of New Hazelton, South Hazelton, Kispiox Valley, Kitwanga, Villages of Gitwangak, Gitanyow, Gitsegukla, Glen Vowell, Kispiox and Hagwilget)

NOMINATIONS FOR QUALIFIED CANDIDATES: Will be received by the Chief Election Officer or a designated person between 9:00 a.m. Tuesday, September 4, 2018 and 4:00 p.m. Friday, September 14, 2018 (excluding weekends) at the offices listed below. Nomination documents may be delivered by hand, mail, email or other delivery service. Originals of the emailed nomination documents must be received by the Chief Election Officer by 4:30 p.m. on Friday, September 21, 2018. **NO NOMINATIONS WILL BE ACCEPTED AFTER 4:00 P.M. FRIDAY, SEPTEMBER 14, 2018.**

QUALIFICATIONS: A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day October 20, 2018;
- resident of British Columbia for at least six months immediately before the day nomination papers are filed;
- not disqualified by the *Local Government Act* or any other enactment from being nominated for, being elected to or holding the office, or be otherwise disqualified by law.

CAMPAIGN PERIOD EXPENSE LIMITS: In accordance with the *Local Elections Campaign Financing Act*, for the 2018 General Local Elections, the following expense limits for candidates during the campaign period apply:

Trustee Electoral Areas 1, 3, 4 & 5 (**Kitimat, Thornhill, Stewart/Meziadin, Hazelton**) - \$5,000.00
Trustee Electoral Area 2 (**Terrace**) - \$5,596.50

THIRD PARTY ADVERTISING LIMITS: In accordance with the *Local Elections Campaign Financing Act*, for the 2018 General Local Elections, the following third party advertising limits apply:

Trustee Electoral Areas 1, 2, 3, 4 & 5 (**Kitimat, Terrace, Thornhill, Stewart/Meziadin, Hazelton**) - \$750.00
